



Privacy policy

Welcome! Car Transport 4U understands that your privacy is important to you. As part of the normal operation of Car Transport 4U's services, we collect and, in some cases, disclose information about you to third parties. This information is only shared as needed to complete your car transport and your information will never be sold to a third party. This Privacy Policy shows you what information we gather from you and how we protect it. By using this website and the content contained therein ("Site") and our services, you consent to the terms described in the most recent version of this Privacy Policy. You should also read our Terms and Conditions of Use to understand the general rules about your use of this Site, and any additional terms that may apply when you access particular services on this Site. "We," "our" and "the transporter" means Car Transport 4U and its affiliates. "You," "your," "visitor," "customer" or "user" means the individual accessing this site and our services. This Privacy Policy is incorporated into, and subject to, the terms of Car Transport 4U's Terms and Conditions of Use.

What personal information do we collect?

We receive and store any information you enter on our Site or give us in any other way. We also collect certain information automatically when you visit our Site. If you choose not to provide this information to us, you should not visit our Site.

Information we collect from visitors of our Site includes information that will be collected automatically using cookies and similar technologies. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your web browser that enables the Site's or service provider's systems to recognize your browser and capture and remember certain information. Cookies collect different aspects of information, including personally identifiable information. This kind of information may include your IP address, browser type, domain names, access times and session information, product usage data, tracking data and other information about your visit to our Site. If you turn cookies off, some features may be disabled. Cookies are used to deliver advertisements to you, to make information we provide to you more relevant and meaningful and to track the efficiency of our advertising campaigns. Cookies are also used to compile aggregate data about Site traffic and Site interaction so that we can offer better user experiences and tools in the future, and to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services.

During your visit, we may also collect information that you provide to us. This may include collection of information during Internet or Social Media interactions, such as requesting information about our services by filling out a website form or other means, as well as vehicle identification numbers related to vehicles associated with our services or services you may request. In connection with vehicle transportation services, we will also collect your name, email, phone number, origin city and state, destination city and state, make and

model for vehicle(s), VIN(s), type of transport (enclosed, open, etc.), pick up type (terminal to terminal, door to door, etc.), time frame for pick up, time frame for delivery and any special instructions you provide. If you request access to any portal that we may provide, you are required to provide the information that is collected, including your email address, name, address and company that you represent, if applicable.

How do we use your information?

Any of the Information we collect from you may be used in the following ways:

1. To personalize your experience and to allow us to deliver the type of content and product offerings in which you are most interested.
2. To improve our website and our services in order to better serve you.
3. To allow us to better service you in responding to your questions and comments.
4. To communicate with you by phone, through email, text messaging and through the Site, including for marketing purposes.
5. To enable us to deliver information to you.
6. To troubleshoot problems.
7. To prevent prohibited or illegal activities.
8. To enforce our Terms and Conditions of Use and Privacy Policy.
9. To share your information with the providers of services or products when you request additional information.
10. To comply with a legal obligation such as court orders, or other legal process; to establish or exercise our legal rights; to defend against legal claims; or as otherwise required by law.
11. To respond as required for a corporate transaction, such as a divestiture, investment, merger, consolidation, or asset sale, or other significant matter.
